Object: adjustment to REACH Regulation (European Regulation for Registration, Evaluation and Authorization of Chemicals) 1907/2006.

Dear Customer,

Referring to what is written into the REACH regulation we send you the following information:

Biella Manifatture Tessili Srl is a downstream users providing articles without intentional release as indicated in the REACH European Regulation. Our firm is conform to the following last REACH updated obligations (August 25th 2020) for downstream users:

- To provide information to suppliers about registration of chemicals present into the chemical products used in the productive processes and/or in the produced articles.
- To provide the certification regarding SVHC substances absence into the chemical products used in the productive processes and/or in the produced articles in a percentage higher than 0.1% by weight.

Our firm has required from our suppliers information about substances included in the article n° 57 of the REACH Regulation, included in the Annex XIV of the Regulation 1907/2006 (as defined by the Regulation 895/2014/CE) and/or included in the updated "Candidate List" of products probably input in the Annex XIV of the REACH Regulation (as updated on January 16th, 2020) or substances included in the Annex XVII of the REACH Regulation, as modified by the European Regulation 474/2014/CE.

The information obtained until now from our suppliers are conform to the 1907/2006/CE and s.m.i European Regulation.

Moreover, Biella Manifatture Tessili Srl makes periodic verifications of the eventual REACH Regulation updates and checks the substances present into the candidate lists, in order to guarantee the accordance to the European Regulation (REACH).

We periodically also ask to our suppliers the updated safety data sheets according to the Annex II of the REACH.

In order to ensure the use of substances in accordance to the REACH regulation, the new products and/or articles which will be insert into the productive chain, are verified before their usage.
